#### (B) EANES SCHOOL ROAD

Tom Arndt informed the Board that due to a newly presented timeline for construction, the District would need to complete a small portion of the Eanes School Road project through a change order on the Bee Cave Road project. The remainder of the project will need to begin the bidding process immediately. The purpose for the escalated timeline is to accommodate the school District's request to have the project completed prior to the start of the new school year.
