RESOLUTION OF THE DIRECTORS OF TRAVIS COUNTY WATER CONTROL & IMPROVEMENT DISTRICT NO. 10 DECLARING CERTAIN PROPERTY TO BE SURPLUS

WHEREAS, a special meeting of the Board of Directors of Travis County Water Control & Improvement District No. 10 (the "District") was held on June 3, 2019;
